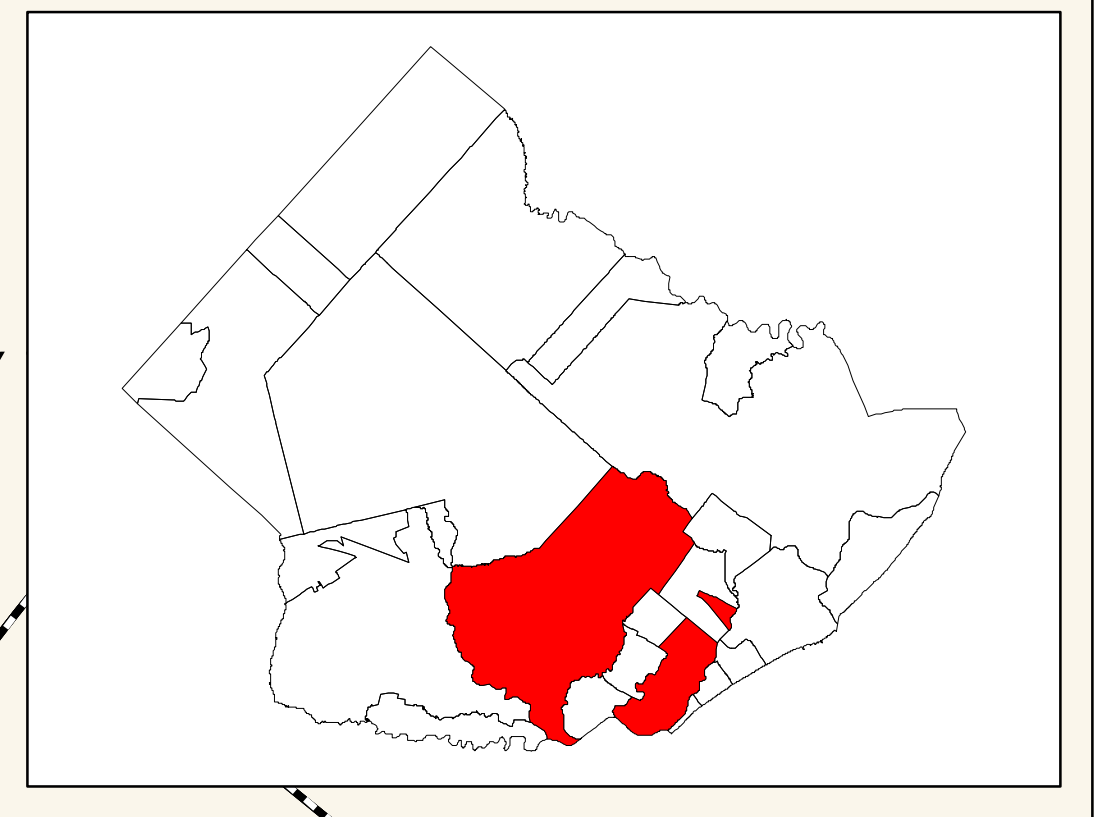


Egg Harbor Township Municipal Zoning Boundaries December 2011 Atlantic County, NJ

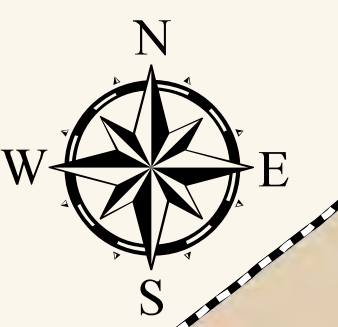
